

## Eastern Partnership Civil Society Forum - annual Forum event, Stockholm, Sweden, 29-30 November 2012

This year there were 583 applications to participate in the Forum, out of which 202 organisations have been selected by the Steering Committee in line with the eligibility guidelines (drawing on shortlists by the country co-ordinators (in conjunction with the national platforms), the working group coordinators, EU facilitators, and the European Union delegations in the six Eastern Partier countries). With 45 per cent new delegates compared with the 2011 Forum, the goal of having at least 40 per cent new delegates was achieved. In addition, 34 per cent has ever elatended any of the three annual Forums to date. In the case of EU delegates, with an increase in applications, 50 per cent for those selected did not attend in 2011.
